There are no fees associated with rescinding this agreement.
- CUSTOMER understands that CUSTOMER has a right to obtain a paper copy of any of the above-described E-Notice/Disclosures or E-Statements. To obtain a paper copy, CUSTOMER must make a specific request to the BANK at the above address. In some cases, research fees specified in the BANK'S Schedule of Fees and Charges may apply to Customer's request pursuant to this paragraph.
- CUSTOMER agrees to notify the BANK immediately if CUSTOMER is unable to access any of the information that has been delivered by the BANK in an electronic form or manner.
- CUSTOMER agrees to provide the BANK with signed, written notice if Customer's e-mail address changes.
